- Audra – At the KAEYC conference on October 1, Audra had the honor of presenting the Outstanding Extended Service Award to Teresa Thompson (BCC Lead Faculty) for her great work and partnership in Butler County. Thanks, Teresa, for all of your hard work!

#### Guest Presenter:

Darla Carter – Family Life Center Safehouse: Darla showed a video about the Safehouse and the programs it offers. The safehouse is open 24/7 and has nine employees. It offers: shelter, a 24 hour hotline, client advocacy, a court advocate, a police response advocate, a sexual assault advocate, the OARS Program, a support group (which deal with narcotic and alcohol

addictions), the Kids Safe program, financial management classes, and community education. The Kids Safe program is not only for kids who have resided in the shelter, but also for children in the community who have been victims of domestic violence, child abuse, or sexual assault. The Safehouse can shelter up to 12 women and children; if they have the need for more space, they can find additional shelter (hotel rooms) for short term stays. The Safehouse receives funding through grants from the Attorney General's office, United Way of El Dorado, Government Grants, and donations. ### **Head Start Grant – Child Start – Jim Garrett**

Child Start has submitted the Head Start grant. There were a “nice group of letters of support” that were sent to Child Start by members of our Task Force and others in the county. Child Start appreciated our support. They do not know when the award announcement will be made, though they hope it will be before the end of December so they will know what the new grant year will bring. ### **Butler Community College Association of Early Childhood Educators (BCCAEECE) Update – Teresa Thompson**

The group currently has 40 members. Through the group, five scholarships to KAEYC were offered (one paid for by the group and four paid for by Smart Start of Butler County). They recently helped with the Numana food packing activity. They are currently working on a Coat Drive with the Grizzly Ambassadors, where they are collecting coats for adults and children that will be distributed during Augusta's Trick or Treat Down the Street. The group meets monthly and has a membership fee of \$5. Membership in the group is open to more than students; professionals in the field of Early Childhood are encouraged to become members. At their next meeting, November 13, will be held at Rainbows United Kids' Point in Wichita and Audra Kenneson will be the presenter. Attendees will receive a KDHE approved certificate for attending the Safe Slumber training that Audra will present. In the Spring they will have a day-long inservice day the last day of March. They are looking at the location for that event. ### **Smart Start & Early Childhood Block Grants – Audra**

The RFP's for these grants were released and they are due within the next few weeks. The directions in the RFP indicate that the budget for Smart Start should show a 14% decrease from the 2011 budget and the ECBG budget will remain the same as 2011. Audra passed the signature page around for specific individuals/agencies that are required for the signature pages. As decisions were made by the Smart Start Advisory Committee, we took into account the outcomes of each activity from previous grant years and the community survey that we sent out over the summer of 2011.
